MOTION: Director Imming moved the Board hold a closed session as provided in section 21.5(1)(e) of the open meetings law to conduct a hearing to determine whether to suspend, expel or exclude a student, unless an open session is requested by the student, or a parent or guardian of the student if the student is a minor. Director Zamora seconded the motion.

The vote on the motion was called and recorded as follows: Ayes: Imming, Zamora, Hunter, Low, and Hester. Motion carried unanimously.

The Board moved into closed session in the Executive Conference Room at 6:15 PM.

The Board returned to open session in the Executive Conference Room by consensus at 6:48 PM.

6:48 PM **EXPULSION OF STUDENT CASE #0116**

Director Hunter stated after the Board's consideration of the evidence presented in the matter of the recommendation to expel Student Case #0116, the Board adopts the findings of fact set out in the Administrative Advisory Council, and the Board concludes the student violated the regulations and rules established by the Board and the continued presence of the pupil is detrimental to the best interest of the school:

MOTION: Director Hunter moved that after the Board's consideration of the evidence presented in the matter of the recommendation to expel Student Case #0116:

- 1) that Student Case #0116 be expelled from the Davenport Community School District for the remainder of the 2001-02 school year;
- 2) that Student Case #0116 will not receive alternative services for the remainder of the first semester. At the beginning of second semester, the student will receive services at the Harrison Street Alternative Program;
- 3) that Student Case #0116 will not be allowed on any Davenport Community School District property or be in attendance at any school event where a Davenport team is participating during the time of the expulsion other than the site of the alternative programming; and
- 4) that the Administrative Advisory Council will meet prior to the beginning of the 2002-2003 school year to determine appropriate placement for Student Case #0116.

Director Low seconded the motion.

The vote on the motion was called and recorded as follows: Ayes: Hunter, Low, Imming, Zamora, and Hester. Motion carried unanimously.
