**EXPULSION OF STUDENT CASE #0221**

Director Clewell stated after the Board's consideration of the evidence presented in the matter of the recommendation to expel Student Case #0221, the Board adopts the findings of fact set out in the Administrative Advisory Council, and the Board concludes the student violated the regulations and rules established by the Board and the continued presence of the pupil is detrimental to the best interest of the school:

**MOTION:** Director Clewell moved that after the Board's consideration of the evidence presented in the matter of the recommendation to expel Student Case #0221:

1. That Student Case #0221 will be expelled from the Davenport Community School District for one calendar year;
2. That Student Case #0221 will not receive educational services during the time of the expulsion;
3. That Student Case #0221 will not be allowed on any Davenport Community School District property or be in attendance at any school event where a Davenport team is participating during the time of the expulsion; and
4. That prior to the beginning of the second semester of the 2003-04 school year, a reentry hearing will be scheduled to determine appropriate placement for Student Case #0221.

Director Guard seconded the motion.

The vote on the motion was called and recorded as follows: Ayes: Clewell, Guard, Hunter, Losasso, Portes, Roberson, and Low. Motion carried unanimously.

### **EXPULSION OF STUDENT CASE #0223**

Director Losasso stated after the Board's consideration of the evidence presented in the matter of the recommendation to expel Student Case #0223, the Board adopts the findings of fact set out in the Administrative Advisory Council, and the Board concludes the student violated the regulations and rules established by the Board and the continued presence of the pupil is detrimental to the best interest of the school:

**MOTION:** Director Losasso moved that after the Board's consideration of the evidence presented in the matter of the recommendation to expel Student Case #0223:

1. That Student Case #0223 will be expelled from the Davenport Community School District for the remainder of the 2002-2003 school year;
2. That Student Case #0223 will receive alternative services at the Harrison Street Program during the time of the expulsion;
3. That Student Case #0223 will not be allowed on any Davenport Community School District property or be in attendance at any school event where a Davenport team is participating during the time of the expulsion, other than the site of the instructional services; and
4. That prior to the beginning of the 2003-04 school year, a reentry hearing will be scheduled to determine appropriate placement for Student Case #0223.

Director Roberson seconded the motion.

The vote on the motion was called and recorded as follows: Ayes: Losasso, Roberson, Clewell, Guard, Hunter, Portes, and Low. Motion carried unanimously.
